

Morning Show Contest: Linkin Park

Every morning from 6:00 AM to 10:00 AM, starting Monday, August 18th, through Friday, August 22nd, LAZER 103.3 morning co-hosts Heather and Wickett will give listeners a chance to win a pair of tickets to see Linkin Park: Form Zero World Tour at the CHI Health Center in Omaha, NE on Friday, August 29th! One lucky listener will be the grand prize winner and their tickets will be upgraded to FLOOR tickets!

To enter, listeners must listen for the cue to call the KAZR-FM studio at 515-244-1033 between 6:00 AM and 10:00 AM. Caller thirteen will have the chance to play the game, "The Answer is 'Heather and Wickett.'" If the caller gives the correct answer, "Heather and Wickett," they will win a pair of tickets. If Caller Thirteen answers incorrectly or cannot provide an answer, the opportunity will pass to Caller Fourteen, and so on. There will be a total of five winners for this contest.

Listeners may only win once. Any listener who tries to qualify on the air or enter online multiple times, including by using someone else's personal information, will be disqualified. The use of software or hardware that allows its user to automate multiple entries into any Des Moines Media Group contest is grounds for disqualification. If there is a dispute over an entry, the person associated with the email address collected at the time of qualifying will be deemed the "entrant," and must be eligible to win under these official rules.
