

LAZER 103.3 Morning Show Contest: Blue October

Every weekday morning from 6:00 AM to 10:00 AM, starting Monday, October 20th, through Friday, October 24th, LAZER 103.3 morning co-hosts Heather and Wickett will give listeners a chance to win an exclusive soundcheck experience with the band Blue October for their show at Hoyt Sherman Place on Sunday, November 2nd. Each prize includes a pair of tickets to the show, access to the band's soundcheck, a Q&A session, a signed poster, and a photo opportunity with the band.

To enter, listeners must listen for the cue to call the KAZR-FM studio at 515-244-1033 between 6:00 AM and 10:00 AM. Caller thirteen will have the chance to play the game, "The Answer is 'Heather and Wickett.'" If the caller gives the correct answer, "Heather and Wickett," they will win a pair of tickets. If Caller Thirteen answers incorrectly or cannot provide an answer, the opportunity will pass to Caller Fourteen, and so on. There will be a total of five winners for this contest.

Listeners may only win once. Any listener who tries to qualify on the air or enter online multiple times, including by using someone else's personal information, will be disqualified. The use of software or hardware that allows its user to automate multiple entries into any Des Moines Media Group contest is grounds for disqualification. If there is a dispute over an entry, the person associated with the email address collected at the time of qualifying will be deemed the "entrant," and must be eligible to win under these official rules. Only one win is permitted per household. KAZR, Lazer 103.3 has the final say as to who wins their contests.

These tickets are PHYSICAL and will need to be picked up at the station located at 1416 Locust St. in downtown Des Moines, right across from the Papa John Sculpture Park. We are open Monday through Friday, 8 am to 5 pm. LAZER 103.3 will not be held responsible if any tickets, certificates, or other prizes cannot be redeemed if an event is rescheduled or cancelled due to circumstances outside of the station's control. Winners are expected to follow all COVID-19 guidelines and any other rules and restrictions put forth by the event organizers and venue. These tickets have an approximate retail value of \$100.
