

CROSS STATION: Des Moines Arts Festival Online Sweepstakes

The Des Moines Arts Festival Sweepstakes is an online contest that will run from Monday, June 1st through Sunday, June 7th on 93.3 KIOA, STAR 102.5, LAZER 103.3, HITS 99.9, 104.1 EZ FM, 104.5 Pure Oldies, 93.7 The Outlaw, ESPN Des Moines, and HOPE 940. Listeners will enter online at any of the station websites for the chance to win a pair of VIP tickets plus merchandise to the Des Moines Arts Festival happening in Downtown Des Moines on Friday, June 26th through Sunday, June 28th.

To enter, listeners must go to the Des Moines Arts Festival Online Sweepstakes contest page on one of the participating station's websites (933kioa.com, star1025.com, 1041ezfm.com, lazer1033.com, or hits999fm.com, oldies1045.com, 937theoutlaw.com, espndesmoines.com, iowashope.com) and completely fill out the entry form on the contest page. Multiple entries on a single stations contest page by an individual will disqualify all entries by that individual. Twelve listeners will be selected at random from the collected entries and be contacted the following week of the contest close.

These tickets are PHYSICAL and will need to be picked up at the station located at 1416 Locust St. in downtown Des Moines, right across from the Papa John Sculpture Park. We are open Monday through Friday, 8 am to 5 pm. Des Moines Media Group and it's corresponding stations will not be held responsible if any tickets, certificates, or other prizes cannot be redeemed if an event is rescheduled or cancelled due to circumstances outside of the station's control.
