

LAZER App Sweepstakes – Phantom Fall Fest

“LAZER 103.3’s App Sweepstakes: Phantom Fall Fest” is an online contest running from Friday, September 25th through Sunday, September 27th at 11:59 PM, where listeners will have the chance to win a pair of tickets to Phantom Fell Fest at Adventureland happening select Fridays, Saturdays and Sundays, starting September 26th through October 31st.

To enter, listeners must download the free LAZER 103.3 mobile app on their device and enter to win before the contest closes on Sunday. The contest officially opens on Friday, September 25th at 12:00 am and participants can submit their entry via a link on the LAZER 103.3 app, directing them to a contest page where they must complete the entry form. Listeners can only enter once throughout the duration of the contest. All entries must be submitted by 11:59 PM on Sunday, September 27th to qualify. Three winners will be selected at random from the collected entries and contacted the following week of the contest.

Listeners may only win once, and any attempt to win more than once will disqualify the listener. Any attempt to win made by a listener using someone else’s email address, name, phone number, or physical address will also disqualify that listener. No automated entries are permitted, and any use of software or hardware that allows the user to enter this contest more than once will disqualify said user from winning. In the event there is a dispute of an entry, the authorized account holder of the email address given at the time of winning will be deemed the entrant, and this person must be eligible to win under these official rules. KAZR, Lazer 103.3 has the final say as to who wins their contests.

By entering this contest, listeners understand and agree that any Personal Data provided during the entry process will be collected and used by Saga Communications, Inc. to identify and communicate with them. In certain circumstances, KAZR, Lazer 103.3 may share that Personal Data with sponsors, advertisers, affiliates, or other partners. These tickets are PHYSICAL and will need to be picked up at the station located at 1416 Locust St. in downtown Des Moines, right across from the Pappajohn Sculpture Park. We are open Monday through Friday, 8 am to 5 pm. LAZER 103.3 will not be held responsible if any tickets, certificates, or other prizes cannot be redeemed if an event is rescheduled or cancelled due to circumstances outside of the station’s control. Winners are expected to follow all COVID-19 guidelines and any other rules and restrictions put forth by the event organizers and venue. These tickets have an approximate retail value of \$140.

No purchase necessary. Prizes are nontransferable and cannot be exchanged or substituted for cash or an alternative prize. Winners must present a valid state ID and w9

to collect the prize. Winners are responsible for all taxes and fees associated with the prizes. This contest is open to all eligible Iowa residents 18 years or older who have not won anything on any Des Moines Media Group Station in the last 30 days, nor any prize valued at \$600 or more in the past six months.

1. No purchase is necessary to enter any LAZER 103.3 KAZR-FM contest.
2. To be eligible to win any prize on LAZER 103.3 KAZR-FM you must not have won anything on LAZER 103.3 KAZR-FM in the past 30 days or any prize valued at \$600 or more in the past 6 months.
